

TURKMEN VISA

To start visa support we need the next documents:

SCANS:

1. Valid international passport (full page that clearly show all text, photo, signature, bar code)
 2. One recent passport-sized photo
- *Quality: the documents must look sharp and clear in electronic format, not checkered, glossy or blurry; scans must be delivered to us in JPEG or PDF format and must be minimum 250KB and maximum 1MB in size*
 - *Black and white scans are not accepted by the State Migration Services*
 - *Scans of paper passport copies are not accepted; they must be scans of originals*
 - *The whole photo page of the passport must be scanned, and to avoid any confusion, it is best if the scan simply shows all four edges of the page*
 - *The original size of passport-sized photo scans must be 3x4 cm minimum and cannot be a Photoshop version of the photo from the passport scan (we will have to print them out on color photo paper, as if we received real original photos from you); a digital passport-sized photo is best*
 - *If you do not have access to a scanner, a digital photo made with a digital camera or smart phone could be acceptable as well, as long as the quality is as described above, and there is no flash/gloss/shine, making any part of the scan unclear*
 - *If there is more than 1 person in a booking, you could scan one page with all photos on 1 paper, as long as you put some form of reference with each photo, so that we are 100% sure who is who*

Personal information:

1. Full name
 2. Current citizenship
 3. Marital status (single, married, divorced, widowed)
 4. Full name and date of birth of spouse
 5. Full name(s) and date(s) of birth of child(ren)
 6. Home address (full address of permanent residence; for expats: not the address of temporary residence)
 7. Name of educational institute (name of institute of last/highest educational certification)
 8. Place of institute (place and country)
 9. Field of study in institute (department, faculty, field/direction/specialization, for example medicine, economics, engineering, linguistics, management, history, law)
 10. Work position (position/function/title of current job, for example economist, engineer, medical doctor, retired, housewife, student)
 11. Place of work (name and place of work and address)
 12. Place of obtaining Turkmenistan visa (embassy and name of city, or on arrival at land border or airport)
 13. Previous visits to Turkmenistan (year, month and purpose)
- *Personal information needs to be submitted in type-written form to eliminate the risk of typos*
 - *The information needs to be compiled separately per person and numbered as above*
 - *The information can be submitted in a separate Word document, Excel file or in the text body of an email message*

There is no need for us to receive anyone's electronic signature, nor employer statements or bank transcripts.

Please be aware that visa support letter application can be submitted to the State Migration Services no earlier than 3 months prior to the scheduled date of departure from Turkmenistan and no later than 4 weeks prior to scheduled date of arrival in Turkmenistan.

LOI application processing is done by the State Migration Services and takes between 5 and 20 working days.
